# New Council, New Plan

Crowthorne Village Action Group (CVAG), a non-political association of residents, is calling on Bracknell Forest Council to review the plan for future development in the Bracknell area.

The recent elections for Bracknell Forest council have ushered in a new administration, and with it an opportunity for a fresh approach to planning sites for new homes. The old council was pursuing an aggressive agenda of building, delivering over twice the required number of houses, according to the office of national statistics. The emerging local plan, identifying sites for construction between now and 2036, continues this trend, identifying more sites than are required. These include 230 homes at Beaufort Park, in the woodland between Crowthorne and Great Hollands, and a further 220 homes at Wellington College, which would necessitate felling hundreds of mature trees. The independent external inspector agreed that the Bracknell Forest plan contained more homes than were necessary.

Said Andy Holley, chair of CVAG "Bracknell Forest is characterised by a modern town centre surrounded by open countryside and individual villages, each with their own distinct character. Strategic green gaps have been identified to maintain that separation. The plan promoted by the old council proposed to erode these gaps and would lead to urban sprawl as Bracknell, Wokingham and the surrounding villages merge into one conglomeration" Andy continues, "We know we need affordable houses for local residents but it needs to be the right homes in the right places. Now there is an opportunity for the new administration to halt the emerging local plan and start afresh"
